

# Pakaflex Pty Ltd – Terms & Conditions of Trade

Definitions: In these Terms and Conditions of Trade:

Siffictions: In these Terms and Conditions of Trade:

Agreement: means any Agreement, order, contract or security agreement entered into for the provision of Goods by Pakaflex to the Customer which will be bound by these Terms;

Terms: means these Terms and Conditions of Trade (and security agreement as defined by the PPSA);

Customer: means a person, firm or corporation, jointly and severally if there is more than one, acquiring Goods from Pakaflex;

Goods: means goods and services supplied by Pakaflex to the Customer including if applicable, Packaging;

GST: means the Goods and tax as defined in A New Tax System (Goods and Tax) Act 1993 as mended;

Intellectual Property: means all copyright, patents, trade marks, designs, formulae, specifications, condidential information, manufacturing processes and all modifications, improvements and derivations (whether registerable or not) owned or licensed by Pakaflex in respect of the Goods:

Pakaflex: means Pakaflex Pty Ltd (ABN 63 550 058 132)

Packaging: means re-usable packaging, stillages and pallets; PPSA: means Personal Property Securities Act 2009.

Basis of Agreement

- 2.1 Unless otherwise agreed by Pakaflex in writing, the Terms apply exclusively to every agreement entered for the sale of Goods by Pakaflex to the Customer and cannot be varied or supplanted by any other condition, including the Customer's terms and conditions.

- Customer and cannot be varied or supplanted by any other condition, including the Customer's terms and conditions.

  Any written quotation provided by Pakaflex to the Customer concerning the proposed supply of Goods is:

  (a) valid for 30 days;
  (b) an invitation to treat only;
  (c) subject to the Customer offering to enter into an Agreement and accepting these Terms.

  The Terms may include additional terms in Pakaflex's quotation, which are not inconsistent with the Terms.

  The Agreement is accepted by Pakaflex when Pakaflex confirms its acceptance of an offer from the Customer in writing or electronic means or provides the Customer with the Goods.
- Pakaflex in its absolute discretion may refuse to accept any offer.
- It is the Customer's responsibility to provide Pakaflex with its specific requirements in relation to the Goods.

  Pakaflex may vary or amend these Terms by notice in writing to the Customer at any time. Any variations or amendments will apply to orders made 2.7 by the Customer after the date of notice.

  (a) claim a general lien over all the Customer's Goods in the possession of Pakaflex, and subject to giving 14 days written notice to the Customer, sell the property by private treaty or public auction, whichever Pakaflex in its sole discretion deems appropriate, and allocate the
  - proceeds to the repayment of its sale costs and expenses and any sum which is due and payable by the Customer; charge the Customer interest on any sum due at the prevailing rate pursuant to the Penalty Interest Rates Act 1983 (Vic) plus 2 per cent for (b) the period from the due date until the date of payment in full:

    charge the Customer for all expenses and costs (including legal costs on an indemnity basis) incurred by it resulting from the default and in
    taking whatever action it deems appropriate to recover any sum due;
    cease or suspend for such period as Pakaffex thinks fit, supply of any further Goods or to the Customer;
    by notice in writing to the Customer, terminate any contract with the Customer so far as unperformed by Pakaffex;

    Where the Customer is an individual and becomes bankrupt or enters into any scheme of arrangement or any assignment or composition
    with or for the benefit of his or her creditors or any dass of his or her creditors generally; or
    where the Customer is a corporation and, it enters into any scheme of arrangement or composition with or for the
    benefit of its creditors or any class of its creditors expensive or has allowidator, administrator, receiver or creeiver. benefit of its creditors or any class of its creditors generally, or has a liquidator, provisional liquidator, administrator, receiver or receiver and manager appointed, or any action is taken for, or with the view to, the liquidation (including provisional liquidation), winding up or dissolution without winding up of the Customer.

- Full legal and equitable title and property in any and all Goods supplied by Pakaflex to the Customer will remain with Pakaflex until:

- Full legal and equitable title and property in any and all Goods supplied by Pakallex to the Customer will remain with Pakallex until:

  (a) the Customer has paid Pakalfiex all amounts owing for the Goods under these Terms; and

  (b) the Customer has paid all other amounts owed to Pakaflex in respect of all Agreements between Pakaflex and the Customer;

  Receipt by Pakaflex of any form of payment other than cash will not be deemed to be payment until that form of payment has been honoured, cleared or recognised and until them Pakaflex's ownership of rights in respect of the Goods will continue.

  It is further agreed that in addition to any rights Pakaflex may have under Chapter 4 of the PPSA until payment of all amounts owing by the Customer to Pakafler.
- the Customer must hold the Goods as fiduciary bailee and agent for Pakaflex and keep separate the Goods until Pakaflex has received

  - payment in full and all other obligations owed by the Customer are met; Pakaflex may give notice to the Customer to return the Goods or any of them to Pakaflex. Upon such notice, the rights of the Customer to
  - obtain ownership or any other interest in the Goods will cease:
  - obtain ownership or any other interest in the Goods will cease;
    Pakaflex will have the right to stop the Goods in transit whether or not part or previous delivery has been made;
    if the Customer fails to return the Goods to Pakaflex, then without prejudice to any other rights and without prior notice, Pakaflex or
    Pakaflex's agent may enter upon and into land and premises owned, occupied or used by the Customer, or any premises as the invitee and
    licensee of the Customer, where the Goods are istuated and take possession of the Goods which remain the property of Pakaflex pursuant
    to this Clause 6 and the Customer irrevocably licenses Pakaflex to enter such premises and indemnifies Pakaflex from and against all costs,
    claims, demands or actions by any party arising from such action;
    the Customer will not deal with any money of Pakaflex in its possession in any way, which may be adverse to Pakaflex;
    the Customer will not encumber or charge the Goods in any way or grant or otherwise give any interest including granting a security
    interest (as defined by the PPSA) in the Goods while they remain the property of Pakaflex;

  Performance of Agreement

  Any period or date for delivery of Goods stated by Pakaflex is intended as an estimate only and is not a contractual commitment. Pakaflex will use its best endeavour sto meet any estimated dates for delivery of the Goods but will in under no circumstances whatsoever be liable for any loss or damage suffered by the Customer or any third party for failure to meet any estimated date.

  The Customer must provide reasonable and proper access to the location specified for delivery.

  The Customer indemnifies Pakaflex against any loss or damage suffered by Pakaflex, its sub-contractors or employees as a result of delivery, except where caused by the negligence of Pakaflex.

  The obligation of Pakaflex to deliver Goods shall be satisfied by the delivery of the quantity of Goods ordered (+/ 10%) or if delivery is installments. (4/ 10%).   The Customer grants Pakaflex a purchase money security interest (PMSI) in all Go

- Costomer. The Customer acknowledges and agrees that the security interest:

  (a) arising under this Agreement will be perfected by Pakaflex prior to the Customer obtaining possession of the Goods;

  (b) is a continuing and substiting interest in the Goods with priority over any other security interest and any unsecured creditor of the

    The Customer will do everything required of it to enable Pakaflex to register and maintain its security interest with the priority Pakaflex
- Pakaflex does not need to give the Customer any notice under the PPSA unless the notice is required by the PPSA and that requirement
- If Chapter 4 of the PPSA would otherwise apply to the enforcement of the security interests created under this Agreement, the Customer
- agrees that sections 95, 120, 121(4), 125, 128, 129, 130, 132(3)(d), 132(4), 134(1), 135, 142 and 143 of the PPS Act will not apply.

  The Customer agrees not to disclose to an 'Interested person' or any other person, any information of the kind described in section 275(1) of the PPSA.

  The Customer must notify Pakaflex immediately in writing of any changes to its name, address, contact details or data required to register financing statement under the PPSA.

  Until Tille in the Goods passes to the Customer, the Customer will keep and maintain all Goods free of any charge, lien or security interest except as created under this Agreement and otherwise deal with the Goods in a way that will prejudice the right of Pakaflex under this
- The Customer irrecoverably grants Pakaflex the right to enter any premises or property of the Customer without notice and without being any way liable to the Customer or any other person, if Pakaflex has cause to exercise any of its right under the PPSA or these Terms and the Customer agrees to indemnify Pakaflex against any such liability.

  Packaging in which or on which Goods are delivered remain the property of Pakaflex (or may be in possession of Pakaflex under Agreement

  Liability

  Except as specifically set out herein, or contained in any warranty statement provided with the Goods, any term, condition or warranty in respect of the quality, merchantability, fitness for purpose, condition, description, assembly, manufacture, design or performance of the Goods, whether implied by statute, common law, trade usage, custom or otherwise, is hereby expressly excluded.

  Replacement or repair of the Goods or re-supply of the Goods is the absolute limit of Pakaflex's liability howsoever arising under or in connection with the sale, use of, storage or any other dealings with the Goods by the Customer or any third party.

  Pakaflex is not liable for any indirect or consequential losses or expenses suffered by the Customer or any third party, howsoever caused, including but not limited to loss of turnover, profits, business or goodwill or any liability to any other party.

  Pakaflex will not be liable for any loss or damage suffered by the Customer where Pakaflex has failed to deliver Goods or fails to meet any delivery date or cancels or suspends the supply of Goods.

  Nothing in the Terms is to be interpreted as excluding, restricting or modifying or having the effect of excluding, restricting or modifying the application of any State or Federal legislation applicable to the sale of Goods or supply of which cannot be excluded, restricted or modified.

  Cancellation

  If, through Circumstances beyond the control of Pakaflex, Pakaflex is unable to affect delivery or provision of Goods, then Pakaflex may

  No purported cancellation or suspension of an order or any part thereof by the Customer is binding on Pakaflex after that order has been

- All specifications, formulae, drawings, illustrations descriptive matter and particulars contained in Pakaflex's catalogues, website and
- All specifications, formulae, drawings, illustrations descriptive matter and particulars contained in Pakaflex's catalogues, website and marketing documents are indicative only, do not form part of this Agreement, and are not representations or warranties of any kind. Any discrepancy will not entitle the Gustomer to rescind this Agreement or seek compensation or damages.

  The Customer must not reverse engineer any Goods provided to it by Pakaflex.

  All drawings, descriptive matter and particulars supplied, remain Pakaflex's property and are to be returned to Pakaflex on demand. The Customer must not publish or communicate any of them to any person or publish or permit them to be copied or communicate them to any other person without Pakaflex's prior consent in writing.

  Intellectual Property

  The Customer acknowledges that it has no proprietary right or interest in the Intellectual Property.

  The Customer must not resister or record or attempt to resister or record anywhere in the world the Intellectual Property or any part or

- The Customer warrants that, where it provides materials for use by Pakaflex or provides manufacturing directions, it is legally entitled to do
- so.

  The Customer indemnifies and agrees to keep indemnified Pakaflex against all liability, losses or expenses incurred by Pakaflex in relation to, or in any way directly or indirectly connected with, any breach of any intellectual property rights in relation to the Customer's manufacturing directions or material provided by the Customer for the manufacture or supply of the Goods.

  Any Intellectual Property provided to the Customer by Pakaflex in connection with the Goods and remains the exclusive property of Pakaflex and with the Compact of the Customer by Pakaflex and must not be copied or communicated to any third party without the express written consent of Pakaflex.

- Subject to Clause 16.3, Pakaflex, in its reasonable discretion if it deems necessary will replace any Goods or re-supply any Goods that do not meet the standard specified in the product description, provided that the Goods may have an acceptable variance Provision of the Warranty is subject to:

- Miscellaneous

  The law of Victoria from time to time governs the Terms and the parties agree to the non-exclusive jurisdiction of the courts of Victoria, the Federal Court of Australia, and of courts entitled to hear appeals from those Courts.

  Failure by Pakaflex to enforce any of these Terms shall not be construed as a waiver of any of Pakaflex's rights.

  If any of the Terms are unenforceable it shall be read down so as to be enforceable or, if it cannot be so read down, the condition shall be severed from these Terms without affecting the enforceability of the remaining conditions.

  A notice must be in writing and handed personally or sent by facsimile or prepaid mail to the last known address of the addressee. Notices sent by pre-paid post are deemed to be received upon posting. Notices sent by facsimile are deemed received on the facsimile machine conformed transmission. confirming transmission
- Pakaflex is bound by the Privacy Act 1988 and takes steps to ensure that all personal information obtained in connection with the Customer will be appropriately collected, stored, used, disclosed and transferred in accordance with the National Privacy Principles. Such information may be accessed by request to Pakaflex in accordance with the Privacy Act.
  Pakaflex requires that the Customer comply with the National Privacy Principles in connection with any personal information supplied to it by Pakaflex in connection with this Agreement.
